



2023 Xtreme Kidz SUMMER Camp (May 28th – Aug. 2nd)

Families,

We are excited about the upcoming activities that have been planned for your child at Faith Chapel's Xtreme Kidz Summer Camp!!! Camp will be held at The Bridge (100 Mike Moore Blvd., Birmingham, AL 35224) from **7:00 AM until 5:30 PM** for children entering K5 through 8th Grade. *Unfortunately, at this time, we are unable to accommodate children with exceptional needs.*

There is a \$140 **non-refundable** registration fee per camper (which includes a season pass to Splash Adventure) with a weekly cost of \$150 per camper (\$125 for the second child of the same household, and "Drop-Ins" (anyone attending less than 3 weeks = \$160 per week). **NOTE: For the safety of all campers, parents/guardians will check-in at the main lobby desk and will not be permitted in the Xtreme Kids lobby area.**

ALL REGISTRATION AND FEES will be completed ONLINE at www.faithchapel.net/kids from April 23rd - May 20th. After May 20th, the registration fee will be \$40, AND PARENTS/GUARDIANS MUST PURCHASE THEIR CHILD'S SEASON PASS FOR SPLASH ADVENTURE.

The camp is open to a limited number of children, so please read all information carefully.

GUIDELINES:

1. **Each child MUST purchase an orange, teal, and grey T-shirt for camp. ALL 3 COLORS ARE NEEDED for field trips and activities.** (T-shirt bundles can be purchased for \$35 each).
2. Campers must be obedient to the teachers, camp counselors, and those in authority during his/her time at camp. Failure to do so could result in loss of privileges, inability to participate in activities and/or field trips and possible removal from camp.
3. Campers must be checked in no earlier than 7:00 AM and no later than 8:30 AM.
4. Campers must be dressed appropriately.
 - a. **ALL 5-6 YEAR OLD CAMPERS MUST BRING A CHANGE OF CLOTHING.**
 - b. Shoes with a closed toe and heel or tennis shoes.
 - c. Clothing will be play clothes. **Faith Chapel is not responsible for damage to clothing or shoes while the children are in attendance at Camp.**
5. Campers must be checked out no later than 5:30 PM. **A fee of \$5.00 cash will be due immediately upon arrival for every 5 minutes interval that you are late after 5:30 PM.** If you arrive between 5:31 PM – 5:35 PM you must pay \$5.00, 5:36- PM – 5:40 PM you must pay \$10.00, etc. Please be a blessing and be on time.
6. Children must bring their lunch and beverage. Snacks will be provided.
 - a. Lunches **must not include candy, gum, or sodas.**
 - b. Lunches must be packed in **paper bags** clearly marked with the child's **first and last names**. **We prefer lunches in a brown paper bag; however, if your child has a lunch box, please clearly mark it with your child's first and last name.**
 - c. All items needed for lunch must be included, such as plastic spoons and napkins.
 - d. All lunch items will be disposed of at the end of the lunch period.
7. Children must not bring toys, backpacks, money, purses or wallets.
8. Xtreme Kidz Camp shirts must be worn on the day we leave campus for field trips.

We are also implementing the safety measures below.

Xtreme Kidz camp staff nor children will be permitted to attend camp if experiencing the following symptoms within 48 hours:

- Temperature of 99 Degrees or higher
- Coughing, runny nose, constant sneezing, or loss of taste or smell
- Are currently quarantined from any other school, sports, or related activities outside of this camp
- Received or been exposed to a person who has received a POSITIVE COVID-19 diagnosis within the last 5 days

***NOTE: If the staff member or camper has tested POSITIVE for COVID-19, he/she must provide a doctor's release and NEGATIVE COVID-19 test result before returning to camp.**

What happens if there is exposure at camp?

- The child/adult will be placed in isolation, and the family (as well as those in direct contact of the exposed person) will be notified and provided with next steps.

TUITION COSTS/ PAYMENT SCHEDULE:

Camp Tuition and fees will cover the cost of the field trips, arts & crafts supplies, and other activities scheduled during normal camp operating hours. A calendar of activities will be provided in our camp newsletter.

ALL REGISTRATION AND FEES must be completed ONLINE at www.faithchapel.net/kids from April 23rd - May 20th. (or until spaces are filled). The \$140 non-refundable/ non-transferable deposit per camper is due at the time of registration (which includes a season pass to Splash Adventure). After May 20th, the registration fee will be \$40, AND PARENTS/GUARDIANS MUST PURCHASE THEIR CHILD'S SEASON PASS FOR SPLASH ADVENTURE.

TUITION:

- **WEEKLY TUITION RATE:** \$150 per camper (\$125 for each additional child of the same household)
- **DROP-IN TUITION RATE:** \$160 per week (*applies to any camper attending less than 3 weeks)
- **LATE PAYMENT FEE:** Additional \$25 if tuition is not received by MONDAY at 5:30 p.m.
- **TO MAINTAIN YOUR CHILD'S ENROLLMENT:** Tuition is due weekly to maintain their enrollment even when a child is absent.

TO ENROLL YOU WILL NEED TO COMPLETE THE FOLLOWING STEPS:

1. Complete and sign the online Registration form that includes our Camp Waiver and Agreement.
2. Complete the online Medical Release form.
3. Submit payment – A \$140 non-refundable/non-transferable deposit per child at the time of registration (which includes a season pass to Splash Adventure). **REMEMBER: After May 20th, the registration fee will be \$40, AND PARENTS/GUARDIANS MUST PURCHASE THEIR CHILD'S SEASON PASS FOR SPLASH ADVENTURE.**
4. Submit separate payment for Xtreme Kidz Camp t-shirts (**\$35 for all 3 shirts that are mandatory for camp trips, etc.**)
